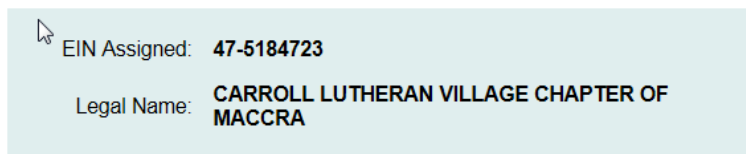

Applying for an EIN is a free service offered by the Internal Revenue Service. Beware of websites on the Internet that charge for this free service.

Remember that each chapter is under the State MaCCRA 501C non-profit. You do not need to file tax form for 501C, just keep a copy of the state document from the IRS.



Web site steps **Apply Online**
The [Internet EIN](#) application is the preferred method for customers to apply for and obtain an EIN. Once the application is completed, the information is validated during the online session, and an EIN

1 Determine Your Eligibility...

- You may apply for an EIN online if your principal business is located in the United States or U.S. Territories.
- The person applying online must have a valid Taxpayer Identification Number (SSN, ITIN, EIN).
- You are limited to one EIN per [responsible party](#) per day.

2 Understand the Online Application...

- You must complete this application in one session, as you will not be able to save and return at a later time.
- Your session will expire after 15 minutes of inactivity, and you will need to start over.

3 Submit Your Application...

- After all validations are done you will get your EIN immediately upon completion. You can then download, save, and print your EIN confirmation notice.

Block associations are made up of neighborhood residents who combine to promote the safety and general welfare, and work to preserve and improve the quality of life in their immediate community.

Tenant associations (or tenant organizations) may be made up of tenants who live in a certain building or development, or may be on a larger scale -- i.e. renters in a city who belong to a county or citywide tenant association.
